IN 2025 WE WELCOMED OVER 350 CHILDREN TO PLAY, SWIM, MAKE FRIENDS, AND JUST BE A KID DURING THE SUMMER ON OUR MULTI ACRE WOODED CAMPUS.</p> <p>DROWNING IS THE SECOND LEADING CAUSE OF DEATH IN CHILDREN. WE ARE COMMITTED TO ENSURING THAT THE KIDS WHO LIVE IN OUR SHORELINE COMMUNITIES HAVE THE BASIC SAFETY AND SWIM SKILLS TO BE SAFE AROUND AND WITHIN THE WATER. IN 2025 WE PROVIDED OVER 3000 SWIM LESSONS TO OVER 1300 CHILDREN. IN 2025 WE ALSO OPERATED OUR COMPETITIVE SWIM TEAM COMPRISED OF OVER 60 YOUNG ATHLETES TO ALLOW THEM TO LEARN STROKES, DEVELOP RELATIONSHIPS AND BE PART OF A TEAM. IN 2025 WE CONTINUE TO EXPAND ADAPTIVE SWIM LESSON PROGRAMS FOR CHILDREN AND ADULTS WITH DISABILITIES TO IMPROVE SAFE SWIMMING SKILLS.</p>
